Rules

- 1. You cannot enter a fish under 15 inches. All fish must be tagged and transported on Ice to the weigh in site and must be dead. (No Livewells with water)
- Any fish brought in that is less than 15 inches will not be weighed and will result in the loss of the weight of the largest walleye from the days bag limit.
- 3. All fish entered will be examined for stuffing.
- 4. Each boat may bring in 6 and weigh no more than 5 walleyes; no more than 2 may be over 20 inches; if more than 6 walleyes are brought in, the contestants will be DISQUALIFIED.
- 5. All rulings by the judges are final.
- 6. Tournament boats must not be closer than 15 feet at any time.
- 7. Boats must not go on shore at any time. Restrooms are at the starting point. If a contestant has any reason for gong ashore, they **MUST** return to the starting point.
- 8. All boats will start and end the tournament at Volden's Pit access.
- 9. All boats must be in by designated time. Any boats in after that will be DISQUALIFIED.
- 10. Any ties will be broken by the weight of the teams largest walleye.
- 11. Boundaries: Anywhere the boat can get safely up to the Marsh Lake Dam
- 12. All Minnesota fishing and US Coast Guard rules apply (Motor HP is restricted to Manufacturer's nameplate).
- 13. Alcoholic beverages are not allowed in boats during tournament.
- 14. Boats will be inspected before and during the tournament.
- 15. Entry fees are non-refundable, unless event is cancelled.
- 16. Life jackets must be worn at all times during tournament hours except at trolling speeds or less.
- 17. Use of binoculars and cell phones is not allowed during tournament hours.
- 18. In case of inclement weather seek shelter on shore.
- 19. Tournament committee and all representatives are not responsible for accidents.
- 20. Flight 1 (Boats 1-35 in at 3:30pm) Flight 2 (Boats 36-75 in at 4:00pm).
- 21. Teams who fished the PJL Memorial in 2022 have until June 30th 2023 to have their entries postmarked to guarantee their spot in this years tournament. On July 1st entries will be open to the public to fill the remaining spots.
- **22.** Any violations of rules or regulations will be grounds for DISQUALIFICATION. All decisions by tournament officials are final.
